Who Are Florida's Practice Extenders?

- Physician Assistants
- Anesthesiologist Assistants
- Advanced Registered Nurse Practitioners
 Nurse Practitioners
 - -Certified Registered Nurse Anesthetists
 - -Certified Nurse Midwives



Who Supervises Extenders and What Level of Supervision is Required ?

- Authorized supervisors
- Levels of supervision
 - Direct supervision
 - Anesthesiology Assistants
 - PAs for routine insertion of chest tubes and removal of pacer wires or left atrial monitoring lines, performance of cardiac stress testing, routine insertion of central venous catheters, injection of intrathecal medication without prior approval of supervising physician, interpretation of lab tests, X-ray studies, and EKG without supervising physician interpretation and final review, administration of general, spinal, and epidural anesthetics
 - ARNPs if protocol so requires
 - Reasonable supervision and control
 - PAs except for tasks requiring direct supervision
 - General supervision
 - ARNPS, unless otherwise required by protocol



What Florida Limitations Govern the Physician Supervisor?

- Delegation limitations
- Prescribing limitations Controlled Substances (ordering vs. prescribing)
- Notice limitations
- Location limitations
- Communication limitations
- Personnel limitations



What Florida Practice Limitations Govern the Extenders?

- Common scope of practice limitations
 - Qualified to do the delegated medical act
 - No controlled substance prescription but ordering acceptable in certain circumstances
 - Role identification
 - Required physician supervision
- Discipline specific scope limitations
 - PAs may not make a final diagnosis
 - AAs perform only select duties
 - All ARNPs must have a protocol
 - NPs, CRNAs, and CMNs have distinct statutory roles
 - Clinical Nurse Specialists (advanced practice nurses)



Who Regulates Them?

- Florida Department of Health
 - -Board of Medicine
 - Council on Physician Assistants
 - -Board of Osteopathic Medicine
 - Council on Physician Assistants
 - -Board of Nursing



Payer Treatment of NPPs

- Differs by payer
 - -Medicare
 - Incident-to billing
 - Shared visits
 - Provider based billing
 - -Medicaid
 - Separate Medicaid handbooks
 - -Commercial
